

**SUBJECT: EXERCISE OF RIGHTS REGARDING PERSONAL DATA PROTECTION UNDER
SECTIONS 7-8-9-10 OF LEGISLATIVE DECREE NO. 196/2003**

Code for the protection of personal data (Legislative decree no. 196 dated 30 June 2003):

Access to the personal data

(section 7, paragraph 1 of the Code)

The undersigned wishes to access his/her personal information and in particular to:

- receive confirmation of the existence of such information, even if not yet recorded;
- receive it in intelligible form;

Request to receive information about the processing

(section 7, paragraph 2 of the Code)

The undersigned wishes to be informed of:

- the source of his/her personal information or the person or source from which it has been acquired;
- the purposes of the processing of his/her personal information;
- the methods of the processing;
- the logic applied to the processing if the latter is carried out with the help of electronic means;
- identification data concerning the data controller;
- identification data concerning the data processor(s);
- the entities or categories of entities to whom or which the personal data may be communicated and who or which may get to know said data in their capacity as designated representative(s);

Request to change the data

(section 7, paragraph 3 of the Code)

The undersigned wishes to obtain:

- updating of the data;
- rectification of the data;
- integration of the data;

- erasure of data that have been processed unlawfully;
- anonymization of data that have been processed unlawfully;
- blocking of data that have been processed unlawfully;
- certification to the effect that the above operations have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated.

Objection to the processing for advertising purposes

(section 7, paragraph 4 of the Code)

- The undersigned objects to the processing of his/her personal data for the purpose of sending advertising materials or direct selling or for the performance of market or commercial communication surveys.

Objection to the processing on legitimate grounds

(section 7, paragraph 5 of the Code)
