Guidelines for authors

Manuscript Submission

Submissions may be made at any time, electronically to idemeyer1@gmail.com. No fees are charged for submission or article processing. Submissions should:

- include an assurance that the article has not been published, submitted, or accepted elsewhere.
- conform to the style conventions of the journal (see below).
- be concise.
- be written in UK English, or in French or Spanish. If submitted in French or Spanish, an abstract in English (of between 750 and 1000 words) has to be submitted together with the article.
- for English language style, follow the University of Oxford Style Guide (www.ox.ac.uk).
- be between 6 000 and 8 000 words in length, references included.
- (for submissions in English) include an abstract (summarising the article as a whole, including its aim, a clear description of its findings) of between 250 and 300 words. The abstract should include at least five key words.
- include a brief bibliography indicating academic qualifications and current professional position, and email contact address, as follows: Charles Ntuli; BA (Oxford), PhD (Lund); Visiting Professor, University of Sao Paolo; cntuli@uu.ac.za

References

References should be provided **in the main body of the text**, by providing the surname of the first author and year of publication in brackets, and the relevant page number, if applicable (following the “**Harvard style**”). For example, "... seems to be supported by the leading scholars (Alston (2001) 222; Benedek (1997) 123)".

At the end of the article, under the heading “References”, **full particulars** of the cited sources should be provided, alphabetically ordered by the first author’s surname, as follows:

Journal articles:

Van Boven T ‘The future of human rights in Europe’ (1989) 6 Netherlands Quarterly of Human Rights 21 (6 is the volume number; 22 the page number where the article starts) (If there are more than seven co-authors, provide the names and initials of the first three authors, then “et al.”)

Books:

Young IM (2002) Inclusion and democracy New York: Oxford University Press

Book chapters:

Hall BG (1983) ‘Evolution of new metabolic functions in laboratory organisms’ in M Nei & RK Coehn (eds) Evolution of genes and proteins (1983) Sunderland, MA: Sinauer Associates, 234-257:

Electronic resources:

For multiple works by the same first author, list alphabetically by subsequent authors; if authors are identical, list by date; if authors and dates are identical, arrange alphabetically by title, setting the dates as, e.g. "2008a" and "2008b". List all authors when there are 6 or less; when 7 or more, list only the first 3 authors followed by "et al."

Editorial Process

All submissions are reviewed by the editors, and may be rejected by them on the basis of focus, style and depth of analysis and research. Screened submissions are subjected to **peer review** by at least two experts in the field.
